Payment of Rs.84082/- will be required through Bank Draft in favour of GM/SAF, Kanpur with Application Form. The advance deposit will be adjusted in the final bill on maturity of the order. <b>In case of cancellation of order on customer's request, Rs.1000/- will be deducted as Service/Cancellation charge.</b></p> <p>5.
